Marilyn Martin, Treasurer, reported \$4987.19 balance in checking account, \$1000 transferred from checking to the Quilt Show account as seed money, \$3000 transferred from Money Market account to checking leaving a balance in MMA of \$28,532.92. Marti Michelle sent 10% of her book sales to the Treasurer. No written report presented.
