Program

The speaker was introduced by Susan Katz

Darilyn Kisch presented “Cool Tools”

She declared, “I Have Notions.” Her theme was “adaptation.”

Definition of stash “store something safely, secretly and in a specified space.”

She said “mine is not a stash—it is just stuff.”

Making something suitable for a new use and purpose—“adaptation.”

The following are the notions that she described

- Blue Tape—no residue
- Tender Tape—1st aide tape sticks to itself but comes right off
- Snag Repair Tool
- Bead Box for bobbins
- “Silicon pencil grip to undo needle screws
- Orvus WA paste
- Mist Sprayer
- Garden gloves—bamboo cling
- Pipe Cleaner—for cleaning machine
- Wonder clips—many sizes
- Flat Clip—can sew over
- Needle case—with a magnet that holds them and spreads them out
- Schmetz non-stick machine needles
- Downey Wrinkle Guard—great out of the washer
- Scissor fobs
- Stacs n Stor-vertical storage
- Cutterz-cuts thread
- Spot on Dot—magnifying lens for plastic rulers
- Mat hanger—sew hooks on
- Nail polish remover pad (single use)to erase marker from rulers
- Story Code QR Code 1 x 1 ½ sheet to attach to quilt label.
- Husky Worktable Home Depot—moves up and down

Quilt chest—three sides and top glass
