Board decided to check the contract to see if there is a natural disaster clause. Board is sending Mickey's supplies to her with a letter asking if her insurance will cover this cost. The board felt this was a normal expense she'd have to bear. A board member thought this might be covered under our insurance.

9. We need to transfer money from the money market account into the checking account for the Quilt Show. Betty has volunteered to do the quilt show.

- 10. Evelyn said the boutique will be in the main rotunda and we can sell our crafts. They want the atmosphere to feel like you're walking through town. We need to give demos. The fee is \$300 for the selling booth and it has been suggested the cost be divided among the ladies that sell. It's a three-day affair, Nov. 23, 24, & 25. Friday the booth will be open 4pm 9pm, Saturday 10am 9pm, Sunday 10am 9pm. The booth is 10X10. Diane suggested the Guild pay for the booth and take 10% of the profits. The board felt the guild should front the money and the ladies selling should be charged a prorated fee. We will also sell the opportunity quilt tickets.
- 11. Betty and Judy stand as quilt show chairs. Michelle will do the ribbons. The quilt show will be the 12th of October 2002.
- 12. The board discussed putting Marti Frolli's flag pattern in the newsletter. No objections were raised.
- 13. A new organization that deals with adult mental problems and/or terminally ill has requested 25-30 Christmas stockings. Diane will put it in the newsletter.
