## ***Quilt Exhibitor Information***

This is a Special Exhibit to showcase Santa Barbara County and the diversity and beauty of the paradise we live in. The inspiration for your piece should be anything related to or located in Santa Barbara County.

For purposes of this exhibit, a **quilt** is defined as a fabric construction consisting of a front, filler layer, and back held together with stitching and made by the member-exhibitor. The piece must be either bound or closed along the edge.

Artists may submit up to 2 works, but only 1 work will be accepted from each artist. Space is limited and we cannot guarantee that all work submitted will be accepted.

Submit your written entry(ies) by April 14, 2016 to Special Exhibit Committee, c/o Irelle Beatie, P. O. Box 189, Summerland, CA 93067.

Your quilt(s) must be completed and delivered to the jurors by July 14, 2016 for the selection process. Linda Estrada will be accepting the quilts for the jury at 688 Rossmore Road, Goleta, CA 93117. Please call Linda at 964-3927 to make arrangements if you wish to drop off your quilt. We will also be accepting entries at the July 14<sup>th</sup> Coastal Quilters Guild meeting. Quilts can also be mailed to Linda at the preceding address. All exhibitors will be notified by mail by September 1, 2016. Exhibit space permitting, additional quilts may be selected according to available space.

**Security Arrangements:** Every effort will be made to protect all quilts. Accounting and surveillance will be strictly planned and maintained. Eating and smoking are prohibited in the exhibit hall. Responsible white-gloved hostesses will try to keep all quilts in view at all times and will discourage touching by viewers. However, CQG show insurance does not cover the quilts. Each owner is responsible for insuring her own quilt(s) for loss and damage.

**Sleeve:** A 4” sleeve must be attached to the back top. This provides a safe and secure means of hanging the quilt. Quilts without sleeves will not be exhibited.

**Label:** An identifying label should be sewn to the quilt on the back of the lower right side stating the quilter’s name, address, telephone number, and name of quilt.

**Packaging:** Each entry quilt must be delivered in its own pillowcase with the maker’s name marked in indelible ink in large letters on the hem regardless of which method you choose to deliver your quilt. This will help keep the quilt clean and facilitate transport.

**Quilt Return:** Quilts that are not accepted into the special exhibit can be picked up at the Coastal Quilters Guild meeting on September 8, 2016. Quilts that will be hanging in the special exhibit will be available for pickup following the show on Sunday afternoon with the rest of the quilts from the show. If you are from out of town, we will make arrangements to return your quilt to you via USPS or UPS.
