### **VISITING NURSE & HOSPICE CARE CONFERENCE ROOM:**

The "Facilities Use Agreement" to reserve the room for August 22 and October 17, 2015 was discussed. Bonnie discussed issues of liability.

Carol Barringer asks that a Board Member also sign the agreement which states that the guild will not sue VNHC.

The guild's liability insurance should cover the activity.

This room is free of charge and thought to be a better site.

The guild is responsible for arranging tables which are on wheels. No tape is allowed on the walls. There is parking in the VNHC parking lot which has 30 available spaces and should be empty on week-ends. The room is clean and modern with nice restrooms. VNHC is anxious to accommodate the guild's needs.

The paragraph in the contract which was crossed out should be signed and dated by Arlene Stepputat of the VNHC organization. The insurance certificate will be sent to VNHC.

Carol Barringer will do this. Bonnie will review for signature.

The workshops are scheduled for August 22 and October 17, 2015.

There will be an online vote to sign the contract which will be confirmed at the August meeting.

# **STORAGE LOCKER:** Carol Barringer

Who has access and how frequently are they going to the locker? We can only access it 3 times a week for 30 minutes each time. Is this a problem? Discussed.

Carol would like to know that we are following the rules and would like to have more control over the use and access of this storage room.

Carol wants to change the lock because it is hard to operate and set.

Carol will buy a new lock.

Everyone who has access should be registered.

The room is full and needs to be re-organized with inventory taken.

The Storage Locker discussion will be added as NEW BUSINESS to the August, 2015 agenda.
